Defiance Lilac Festival Vendor Guidelines:

In celebration of the City of Defiance's flower, we encourage and appreciate vendors highlighting an item that is purple or lilac related.

- The Lilac Festival will be held in the streets of Downtown Defiance rain or shine.
- All spaces are first come first serve. Vendor spaces sold out in 2025 so please be sure to return this application ASAP. Application deadline is April 10th, 2026, or until all vendor spaces are filled.
- Your space will be assigned to you. Applications are processed and vendors placed on the event map in the order applications are received. You will receive an email the week prior to the event with your booth number, map, and arrival instructions.
- Set-up begins at 7:00 am and must be completed by 9:15 am. Only one vehicle per vendor is allowed in the event premises at one time.
- No vehicles are allowed within the event premises once set-up is completed.
- Tear down may begin at 4 pm, unless you are otherwise notified by the festival committee.
- Each vendor is responsible for having appropriate money/change throughout the day, as well as their own set-up, tables, sunshade, electric, etc. Electricity is unavailable so please plan accordingly.
- The Defiance Lilac Festival & Street Fair is a Cultural Arts and Craft Show. No for-profit business will be allowed booth space for the purpose of promotion. No resale of items will be allowed. Final determination of booth eligibility will be determined at the discretion of the Lilac Festival Committee.
- Once your application has been approved by the Committee, the application fee is nonrefundable.
